# 1. Programmes of the CRG:

- 1.1. <u>Winter Course</u>: The Third Winter Course on Forced Migration successfully concluded in December 2005. As in the previous years the course was guided by the recommendations of an Advisory Body. The course succeeded in broadening the participation, organizing field visit to new area, including new issues of concern in the curriculum and having a more diversified faculty that included members of CRG, experts of India and other countries of South Asia and from other regions. For the first time the course had participation from Africa. It succeeded in improving its standard, corrected past mistakes and was able to highlight certain issues as perennial concerns of the programme such as statelessness, trafficking, violence, right to return and the quality and nature of humanitarian work. The course highlighted the lessons of the Tsunami relief work. The other noticeable improvements in the course are: (a) the course is able to develop the links with new institutions in India and abroad; (b) deserving participants are helped to carry on their work even after the course is over as part of the programme; (c) The course shows promises of developing into a full fledged programme with different segments; (d) the distance segment of the programme is on the way to become an innovating and compact phase in the course.
- Dr. Paula Banerjee, Coordinator of the Course, handled all the activities smoothly and efficiently with the help of Ms. Shreyashi Cahudhuri, the Programme associate.

The progrmme was supported by the Government of Finland, UNHCR and the Brookings Institution. The detailed report on the course has been printed and widely distributed (Annexure - I) Already posted in our website www.mcrg.ac.in/rp.htm

1.2. **Programme on the IDPs**: The programme on IDPs during the year under consideration was divided into two parts - research and advocacy. In the research segment CRG carried out a South Asian study of the Voices of the IDPs in various camps in different parts of India, Nepal, Bangladesh and Sri Lanka. The reason for conducting the study was to find out the opinions of IDPs and their awareness regarding national and international instruments of protection of the IDPs, propose ways of policy formation in which the voices of the IDPs could find adequate space. The study is complete and the preliminary report is ready. CRG now plans to publish the detailed report in form of a volume.

The study was conducted under the leadership of: Dr. Asha Hans (Santa Memorial Rehabilitation Centre, Bhubaneswar, Orissa); (ii)National Peace Council of Sri Lanka, (iii) Suraya Begaum & Meghna Guha Thakurta, (Research Institute of Bangladesh and Dhaka University); (iv) Nepal Institute of Peace, Nepal; (v) Anasua Basu Ray Chaudhury, (Centre for the Study of Developing Societies, Delhi); (vi) Anuradha Bhasin Jamwal (Kashmir Times); (vii) Dr. Paula Banerjee (CRG); (viii) Madhuresh Kumar, CRG and (ix) the Director.

Under the Advocacy segment the CRG continued its work of translating and publishing in different languages the UN Guiding Principles. Two more translations came out - in Bodo and Meitei. Initiative has been taken to publish this in Hindi also. An Urdu translation of the CRG book in internal displacement in South Asia will be also published.

As part of the Advocacy work the CRG organized three lectures by Robert Kogod Goldman. Robert Kogod Goldman is the Professor of Law & Louis C. James Scholar; Co-Director, Center For Human Rights and Humanitarian Law, American University, Washington College of Law, Washington, D.C., USA. He delivered lectures on "The Guiding Principles on Internal Displacement"; "The Principles' Normative Status" and "The Need For Effective Domestic Implementation" in Kolkata, Pune and Delhi in collaboration with respectively the West Bengal Political Science Association, Bhowanipur Education Society College, Kolkata, and Indian Society for International Law, Delhi.

There is plan to institute such public lectures more in future. The CRG also held intensive workshop on the lessons of relief work after the Tsunami. The report of the workshop was circulated widely. (The report is enclosed as **Annexure III**). It was authored by Paula Banerjee and Sabyasachi Basu Ray Chaudhuri. The members can see the report on the website of CRG (in the Archives section). The Tsunami workshop was supported by Brookings Institution and the journal, "Forced Migration Review". An abstract of the report was published in the Forced Migration Review. Dr. Paula Banerjee represents the CRG in the advisory board of the FMR.

Three other segments of the programme of the IDPs remain to be completed: (a) a website on IDPs in Nepal; (b) holding a workshop on the IDPs in North-east; (c) a workshop on the IDPs situation in Burma. The CRG will have to take immediate steps to successfully complete the programme.

Dr. Paula Banerjee, Sabysachi Basu Ray Chaudhury and Maduresh Kumar had at different stages participated in the implementation of the programme. Dr. Sabyasachi Basu Ray Chaudhury is now in charge of the programme. The IDPs programme is fully supported by Brookings Institution.

The IDPs programme partially got encouragement from another programme of CRG under which a workshop on rights and globalisation was held in Guwahati in April 2006.

1.3 <u>RESEARCH WORK ON AUTONOMY</u>: The Ford Foundation supported research programme on "Autonomy in India" ended in September 2005. It was a two year programme which began in 2003. The last year's Annual Report (2004-05) mentioned the progress of the project. The highlight of the programme was (a) certain theoretical findings on the relation between autonomy and democracy; (b) a comprehensive critical enquiry into different aspects of the political constitutional arrangements for autonomy in India; (c) and two major publications. We are expecting one more publication out of this programme. A detailed report is attached herewith as <u>Annexure -IV</u>. The report has also been put on CRG's website. Another important aspect of this programme is that it attracted international attention. The Director was invited by Columbia University, Cornel University and Bochum to discuss our research work. The

Director was also invited by the University of Uppsala to speak on the Indian experiences of autonomy. The Compendium that CRG brought out as a part of this work has earned special appreciation. There is a suggestion to revise the compendium and have a second edition to be published by a well known international publisher. It has to be followed up. Dr. Samir Kumar Das and Dr. Sabyasachi Basu Roy Chaudhury were the joint-coordinators of this programme and the success of this programme owes a lot to them.

- 1.3. <u>SOCIAL JUSTICE IN INDIA</u>: The research programme on Autonomy evolved into a research work on research and dialogue programme on the dynamics of Social Justice in India. This programme too is supported by the Ford Foundation. While the structure of the programme is in many ways similar to the preceding one. It will have more emphasis on collective research, field work, ethnographic studies, and wider participation base and more dialogues. Members will get to know the progress of this programme in next year's Annual Report. They will also be kept informed of the progress of the programme on regular basis. Between the commencement of the programme (1 March 2006) and 15 July 2006 we have held two consultative dialogues on research design and possible significant themes one of these two concentrating the experience of West Bengal. Dr. Samir Kumar Das is the Coordinator of this programme.
- 1.4 RESEARCH ON "Regional Initiative of the Rights to Sustainable Livelihood and the Enabling of Social and Political Participation": This is a collaborative South Asian Project led by the Consortium of Humanitarian Agencies, Sri Lanka. The main part has been completed in the calendar year of 2005 (Report on this programme is available from the last year Annual Report 2004-05).

As part of the programme there was one major research article by Madhuresh Kumar, a data base of relevant institutions and activities and the successful completion of the task of developing an educational package for the training of rights as indicated by the research theme. The design developed by CRG has been appreciated widely and adopted by all the partners of the programme. For implementation of the educational design an intense workshop in Guwahati was held on 22-23 April 2006. The programme has entered into its last phase. At least one more similar workshop will be held to improve the design of the educational package after which if will be published for wider dissemination. Members are requested to visit the CRG website (<a href="http://mcrg.mcrg.ac.in/research.html">http://mcrg.mcrg.ac.in/research.html</a>) for the report of the Guwahati workshop. The programme was run by Madhuresh Kumar whose dedication deserves appreciatiaion. The programme has huge potential and members are requested to think of how to carry forward CRG's work in the context of rights and globalization. In fact this programme will help CRG's research and advocacy work on displacement, also the work on the issues of social justice.

- 1.5. Rehabilitation of Women Affected by Erosion and Flood in West Bengal: The project was sanctioned by the National Commission for Women, New Delhi. Ms. Krishna Banerjee is coordinating this project under the guidance of the Project in-charge Dr. Paula Banerjee. An interim report was sent to the National Commission for Women. The work is still continuing. However there has been delay in completion of the work. Final research report will have to be completed soon. (Interim report is enclosed as Annexure V).
- 1.6. <u>MEDIA RESEARCH WORK</u>: In order to continue CRG's work in the field of Media, Gender and Human Rights, two proposals were sent: to WACC on (a) "Electoral, Ethnic and Resource Politics Masculine Images in the Media" and to the American Centre (b) "Gender, Media and Justice in South Asia". In the case of the WACC the proposal was approved long back (October 2005) but the fund is yet to come; and in the second case the approval is still awaited.

1.7. <u>Collaborative research</u>: The CRG has entered into a Memorandum of Understanding (MoU) with the International College de Philosophy, Paris, for a joint research and seminar programme on mutually agreed upon issues. As part of the MoU the first conference will be held in Paris on 2-4 November 2006. The CRG has also relation of cooperation with the Maison des Sciences de l'Homme (MSH), Paris, on the basis of which in February 2005 a Conference was organized on the theme of "Conflicts, Law and Constitutionalism". A CRG-MSH volume based on the proceedings of the conference has been planed. On the basis of that understanding the Director of the CRG was invited to France and Tunisia last year. A bigger international network has been formed. CRG is a part of it. In this connection members will be happy to know that the CRG has now research connection with several reputed universities abroad. As a result of this growing cooperation several reputed personalities have visited the CRG, attended its dialogues and have given public lectures.

<u>Journal</u>: <u>Refugee Watch</u> - The journal 'Refugee Watch' is now being used as study material in the Winter Course. Dr. Paula Banerjee was editor till 2005. She relinquished the editorship of the journal with the publication of a combined issue (Special Issue Nos. 24 - 26 December 2005) and Director, Dr. Ranabir Samaddar is now the editor of the journal. A new advisory team has been constituted.

The journal "Refugee Watch" publication is supported by the fund available from the Winter Course. The volumes on Autonomy have been supported by the Ford Foundation. Publications

under the Research Paper Series are supported by the funds available under the distinct research heads.

In this connection it is important to note that CRG book publications have received wide attention and have been reviewed widely in different journals and newspapers. Some of these reviews are available in the office and if the members are interested may kindly go through it.

3. <u>Website</u>: One of the most notable features of the CRG is its website and the information dissemination structure. The website was designed indigenously after several experiments and now it is recognized as an exhaustive database of CRG activities. The website has data information on all its research, conferences, dialogues, publications and orientation and training programmes.

The website is important as an interactive site also in the distance education phase of the Winter Curse. The website contains the complete archives of all issues of Refugee Watch and has a special section called 'Refugee Watch Online'. The CRG does not have contrary to the usual procedure of any specially designated Webmaster to run it. The maintenance of the website is done primarily by Samaresh Guchhait with the advice of the Director and inputs from other members. Also Mr. Ayan Mukherjee and Mr. Madhuresh Kumar put in huge efforts for the construction of the website. Thanks are due to them.

Though the website has earned appreciation from all quarters yet there is distinct scope for improvement. For instance, 'Refugee Watch Online' can be improved and turned into an interacting, opinion expressing forum of different views. Similarly the archive section can be improved. All members are requested to come forward to take greater responsibilities relating to the maintenance and improvement of the website.

The website is maintained by the fund available from the grant from the Ford Foundation and the CHA.

- 6.1. An Asset Register has been prepared of assets of the CRG including Library books. The Register is maintaining and updated regularly and it is open for inspection.
- 6.2 <u>Library Holdings</u>: The CRG library is now developing as a referral library for social science research which is equipped with books, documents, manuscripts, journals and CDs. Needless to mention, the library has been a source of support to various research activities of this centre, also various research scholars, students, faculty members of colleges, other research institutes, universities and NGOs. It contains around 676 books relating to mainly to gender, migration, displacement, autonomy, law, justice and literature. Among 676 books, 80 books are gifted by institutions and individuals.

CD section contains films on wide ranging topics like human trafficking, gender, ethnic conflict and violence, migration and about different folk traditions of the country. A very interesting CD is on exclusively Naga songs.

It has a rich documentation section where we keep the journals and magazines of various institutions. In the documentation section we have an exclusive collection of *monthly compilation of newspaper clipping on Northeast India*. We have various reports on socio economic conditions of displaced people of the Kashmir Valley.
