### SECTION ONE RESEARCH PROGRAMMES (Completed)

#### 1.1 Cities, Rural Migrants and the Urban Poor – Issues of Violence and Social Justice

This research programme, supported by the Ford Foundation, was begun in 2014. After completion of the first two years the funding for the project was interrupted though research in CRG continued. Funding restarted in 2017 and the project was completed in December 2017. The project was guided by Ranabir Samaddar with the help of Ritam Sengupta as the Research and Programme Associate. The research was based on three big cities (Delhi, Kolkata, and Mumbai) and one small town (Siliguri) in India. It focused on a comparative approach towards the issues of city planning, migration practices, and social justice for the urban poor. Attention was given primarily to the formation of the category of migrant workers and the various identities and locations of their existence within the city space. #### 1.2 Experiences, Aspirations and Struggles: A Study of the New Middle Class in Two Indian Cities

CRG was approached by Tata Institute of Social Sciences, Mumbai, to take part in the ICSSR funded project on *Experiences, Aspirations and Struggles: A Study of the New Middle Class in Four Indian Cities*. It was later decided by the Advisory Committee of the project to focus on two Indian cities– Mumbai and Kolkata. The aim of this study was to understand lived experiences of the middle class and describe these experiences through examination of identity, exclusion and the processes associated with consumerism and its purported shift to a new lifestyle. TISS conducted research in Mumbai while the segment on Kolkata was done by CRG. CRG appointed Somdatta Chakraborty as Research and Programme Associate for the project, who in addition to looking into primary and secondary literature, conducted a series of interviews to add depth to the study. She completed and submitted the project as per TISS requirements.

#### **RESEARCH PROGRAMMES (ONGOING)**

#### 1.3 Data Centres in India

This is a collaborative project with Western Sydney University. The work continues in the wake of the attention devoted by CRG and University of Western Sydney to the problematic of logistics as a governing mode in contemporary capitalism. The project sought to study data centres and some of the select dimensions of data management in India in five ways: (a) Inquiry into the evolution of public data management in India in terms of regulatory mechanisms and standards (b) Mapping Belapur in Navi Mumbai that houses a cluster of data centres of various financial institutions(c) Examination of a state government data centre in West Bengal that will tell us of the informational fields of local trade, health, taxation, security, and most importantly, land, land revenue, and land utilization records (d) Study of the Unique Identity of India Authority (Aadhar project) as an instance of public-private partnership in generation and management of data about transactions between the residents and various public and private entities, at the national scale, and the shifting modes of public-private data management it imagines and engenders(e) issues of data secrecy, government guidelines on IT infrastructure, duplication, piracy, etc. The research was conducted under the guidance of Ranabir Samaddar with Ritam Sengupta as the Programme and Research Associate. A panel discussion on the theme has been arranged for 2 September 2018 as part of the international conference on *Infrastructure Across Frontiers*.

#### 1.4 Social and Political Mapping of Popular Movements, Logistical Vision and Infrastructure of India

The project began on January 1, 2016 and developed into a three year project funded by Rosa Luxemburg Stiftung. For the concept note, list of researchers and experts, events and publications, see http://www.mcrg.ac.in/RLS\_PML/RLS\_PML\_Home.asp

This project has the following two segments:

(i) *Popular Movements in Bihar and Bengal* -This developed into a detailed study of mobilizations in Bengal --- the refugee movement, the food movement, the anti tram fare hike and teachers' movements during the 1950s followed by the Naxalbari movement and other popular movements in the districts of Bengal during the 1960s and early 70s. The segment on Bihar raised the issue of social justice as the core of popular politics with two research segments--- the backward caste movements led by Karpuri Thakur and the JP movement. In the last two year 9 researchers have worked on these themes, but more significantly, the research segments have been reviewed and debated by 33 experts. These research segments will be published this year in a book edited by Professor Samaddar and published by the Social Science Press.

(ii) A Social Mapping of Infrastructure Logistics and India's Look East Policy -This project examined how Look/Act East, essentially a policy of fostering ties to the regions on the Southeast of India, become linked to a domestic policy of governance, with the Northeast as its intermediary, to project new logistic opportunities in an increasingly interconnected world. Envisaged as a natural bridge between Southeast and East Asia and India, the Northeastern region was sought to be seamlessly integrated within a new paradigm of development with the presupposition that linkages to a wider Asian region would elevate the region out of its underdevelopment and consequent insurgency to a new era of advancement through a network of connectivity, communication and trade. The research focuses on logistical governance in India's Northeast and its linkage to networks in Southeast Asia. It contends with the politics and economics of routes in the Asian context, issues of global logistical governance, and finance capital and infrastructure in the Indian scenario but situated within a broader Asian and global context. An advance contract for publishing the research segments has been signed with Routledge, and will be edited by Ranabir Samaddar and Anita Sengupta.

This is the final year of the project and the research agenda for 2018 was to organise collaborative workshops and conferences for the purpose of dissemination of research beyond the confines of Kolkata.

# 2.1 Sixth Critical Studies Conference on 'Refugees, Migrants, Violence and the Transformation of Cities', 23-25 August, 2017

#### Refugees, Migrants, Violence and the Transformation of Cities

The Sixth Critical Studies Conference was held over the 23rd, 24th, and 25th of August, 2017, and was organized by CRG in collaboration with the Ford Foundation. The theme of the conference was *Refugees, Migrants, Violence and the Transformation of Cities* and it featured a keynote address, a plenary session discussing key texts of urban studies, a film screening, and eleven panels of presentation. Cities world over are attracting increasing numbers of people fleeing villages, small and big towns, other countries and continents to escape conflicts, wars, violence, environmental degradation and natural disasters. Political, economic, social and cultural reasons have combined in this phenomenon of massive and mixed migration. Displacements being protracted, immigrants arrive

often to stay. Cities are facing the brunt of this development and are imperceptibly or radically being transformed. In this background, the Sixth Critical Studies Conference was an interdisciplinary attempt to map in a comparative framework, the restructuring of cities under the impact of refugee and migration flows. It explored cityscapes in various parts of the world as inbuilt destination spaces of refugee and population movements, such as irregular and subsistence labour as guest workers, trafficked victims, smuggled women and children, immigrant workers in care and entertainment industry, and above all masses of urban refugees and migrants as inbuilt components of their formation, today's cities constitute and contest at the same time the parallel scales of the local, national, and the global; how as migrant spaces, cities become the battleground of discourses on rights, security, economy, citizenship, populism, and culture; and yet how cities can develop as public spaces and spheres of participation in which varied actors negotiate diversity including race, class and gender. With this broad aim, this research conference brought to light in historical and comparative perspective the urban experiences of restructuration.

## 2.2 Roundtable on Étienne Balibar & Immanuel Wallerstein's Race, Nation, Class: Ambiguous Identities

Jointly organised by Calcutta Research Group & Rabindra Bharati University in collaboration with Haus der Kulturen der Welt, Berlin, this roundtable-organized twenty-five years after the publication of the English-language edition of the collection of essays by Étienne Balibar and Immanuel Wallerstein, Race, Nation, Class (RNC) 1-turned out to be a continuation of the discussions in and around India, about the issues the book raised, which had begun almost as soon as it was published. The participants were Professors Paula Banerjee (Sanskrit College & University, Kolkata), Pradip Kumar Bose (Centre for Studies in Social Sciences, Kolkata), Nirmalya Narayan Chakraborty (Rabindra Bharati University (RBU), Kolkata), Anup Dhar (Centre for Development Practice, Ambedkar University, Delhi), and Mary E. John (Centre for Women's Development Studies, New Delhi). Their observations were supplemented by comments from Professor Sabyasachi Basu Ray Chaudhury (Rabindra Bharati University) Professor Ranabir Samaddar (Distinguished Chair, CRG, Kolkata), Professor Bankim Chandra Mandal (Rabindra Bharati University), as well as faculty members, and students from other universities and their collaborators. The roundtable, ended up becoming a historically informed dialogue from several locations across India, predictably also one that sought to enquire about the role of the insights generated in discussing specific Indian concerns and questions. ## 2.3 A Conference to Commemorate the 150th year of the Publication of Karl Marx's Capital (Volume One) - Capital in the East

The first volume of Karl Marx's *Capital* (Volume one), published in 1867 was considered for long throughout the world as the most important guide to understand the ills of capitalism, the origin of the working class, and the materiality of the exploitation of the workers. The book was translated worldwide in numerous languages, and arguably became the most important book in the last two centuries. Then in the last three decades, as socialism collapsed and neoliberal capitalism spread to various corners of the globe, *Capital* became a redundant treatise to many. Its analysis was held outdated, fit for only intellectual consumption and curiosity. However, the world financial crisis of 2008 brought *Capital* to renewed attention of critical theorists, social scientists, and progressive movements. Its analyses are being considered even more relevant today. Newspapers have focused attention on the contemporary relevance of many of its arguments. In the developing world, the drive towards developmentalism, expansion of market, financialisation, weakening of state's welfare services, rampant privatisation, and boundless exploitation of natural and human resources have become major issues of concern. In this milieu, *Capital* has returned to attention. The conference

## SECTION FIVE Distinguished Chair Report

 In the year under consideration, Ranabir Samaddar continued his research on "Visiting the Postcolonial Age of Migration", provisionally built around the theme of interrogating Stephen Castles' (co-authored) classic "The Age of Migration". The projected work will have eight to nine chapters: (a) Reflection on Stephen Castle's work and methods by revisiting "The Age of Migration"; (b) postcolonial interventions in methods of studying forced migration; (c) historical reflections on late nineteenth century to early twentieth century immigration flows; (d) ecological migration and precarious labour; (e) refugee labour, immigrant economies, and global capitalism; (f) power, responsibility, and humanitarianism; (g) transitional justice in the context of forced migration; (g) Current metaphors of migration - "waves", "crisis", "autonomy", "exception", etc.; (h) states, nationalised citizenship, and statelessness.

- He has most of the projected chapters, they have to be thoroughly revised, and the introductory chapter has to be written. Besides working at CRG on this book, for further research, he accepted two visiting fellowships in the year in consideration: O'Brien Residency at McGill University, Montreal (October-December 2017) and Visiting Fellowship at the IWM, Vienna (March-April 2018).
- 3. The work will need one more year to complete. It started in 2016.
- 4. Besides giving public lectures at CRG programmes, he also presented his research findings at McGill University, Montreal, York University, Toronto, Binghamton University, New York State, Council for Social Development, Hyderabad, Goethe Centre, Hyderabad, TISS, Patna, The Apatride Society of the Political Others, Athens, Haus der Kulturen der Welt, Berlin, Port Labour Cooperative, Genoa, Carl von Ossietzky University, Oldenburg, Graduate Institute of International and Development Studies, Geneva, and the University of Connecticut, Connecticut.

## SECTION SIX Library, website, and assets

**6.1 Library**: The Library and Resource Centre of the Calcutta Research Group (CRG) has a vast collection of resources which includes books, documents, journals, manuscripts, research papers, working papers, thesis, census reports, audio, video and data CDs. The library contains 4867 books and 151 CDs including audio, video, data and Lecture CDs relating to law, gender studies, forced migration, food, environment, urbanization, justice, autonomy, displacement, literary works, minority rights, media, advocacy material, child right, human rights, Northeast migration, and Look East policy. CRG has an exclusive collection of newspaper clippings on Northeast India and archival materials on forced migration. CRG is a regular subscriber of e- journals like JSTOR, and Economic and Political Weekly (EPW). The CRG library is digital, allowing research scholars, students, faculty members of

colleges, universities, research institutes and NGOs to avail the online catalogue. Approximately 408 registered users can access CRG digital library.

CRG has transferred its book holdings to HB 232 (Ground floor) where its library is now situated. At the moment, the library hours are restricted. Mr Rajkumar Mahato had been appointed as Library Assistant from 1 December on a part time basis with a salary of Rs 10,000. There is proposal to extend library hours and keep it open for the first half on Saturdays.

A Library Committee consisting of Ranabir Samaddar, K K Bannerjee, V Ramaswamy, Purna Banerjee and the Director was constituted for determining library rules and modes of operation. The Director will request the members of the committee to join and call for a library committee meeting at the earliest. Ranabir Samaddar noted that there was a possibility that the Paresh Chakraborty collection could be handed over to the CRG library. However, library committee members will have to decide whether given space constraints at the present location the entire collection can be accommodated.

**6.2 Website**: The website of the Calcutta Research Group (www.mcrg.ac.in) is a significant and informative site. It has a collection of information, resources and publications which helps researcher, teachers, media peoples, scholars, and human rights activists. It is designed for presenting papers, abstracts, relevant documents, online registration, notifications, and links while organizing conferences, dialogues, workshops and seminars, and promoting different upcoming programmes as well as advertising past ones. It is significant as an online distance education system. It hosts an e-source centre with basic and advanced search engines by which registered researchers, teachers, media peoples, scholars, and human right activists can access relevant documents, books, links etc. It also hosts the online co-publication of *Refugee Watch* "Refugee Watch Online". RW Online is updated and maintained by Samata Biswas. Samaresh Guchhait looks after the designing, development, and regular updating of the website with the help of Research & Programme Associates. He also works as system administrator to maintain the windows 2003 server, mailing system, and provides technical support.

A more enhanced and upgraded version of the website was uploaded by CRG in March 2018. It remains a work in progress given the large amount of data that had to be transferred from the old version of the website. We will be happy for inputs from members about broadening the utility of and access to the website.

**6.3 Assets**: Two new computers were purchased. Two tables were purchased, one for the library and another for Senior Fellows at the CRG office. Four steel almirahs were purchased for the library. Twenty chairs were purchased for the CRG conference room. For further information, CRG's Asset Register may be checked. It is updated regularly.

#### SECTION SEVEN Research and Administrative Staff

#### 7.1 Research and Administrative Staff

On 1 November 2017 **Anita Sengupta** joined as Director. Paula Banerjee who had held the post of Honorary Director from 2015 resigned as she joined as Vice Chancellor of Sanskrit University. In addition to her duties as Director, Anita Sengupta continued to coordinate the CRG-RLS project on *A Social Mapping of Infrastructure, Logistics and India's Look East Policy* and is now also coordinator of the CRG-RLS project *Research and Orientation Workshop and International Conference on The State of the Global Protection System for Refugees and Migrants*. Institute of Advanced Studies (NIAS), Bengaluru. Somdatta Chakraborty and Ritam Sengupta left on completion of their projects. Priya Singh continued as Research and Programme Associate for the CRG-RLS project on *Popular Movements in Bihar and Bengal* and she continues to be primarily responsible for *Refugee Watch*. Two new Programme and Research Assistants Shatabdi Das and Ankita Manna joined for the CRG-RLS project *Social and Political Mapping of Popular Movements, Logistical Vision and Infrastructure of India* from 1 March and 1 February 2018 respectively. Apala Kundu joined as Research and Programme Assistant from 1 April 2018 for the CRG-RLS programme *Research and Orientation Workshop and International Conference on The State of the Global Protection System for Refugees and Migrants* and Aditi Mukherjee joined as Research and Programme Associate for the same programme from 1 May 2018.Atig Ghosh continues as our Honorary Research and Programme Associate.

Priva Singh has been Research and Programme Associate at the Calcutta Research Group for the RLS-CRG project Social and Political Mapping of Popular Movements, Logistical Vision and Infrastructure of India since January, 2017. She has been assisting Professor Ranabir Samaddar with the Popular Movements in West Bengal and Bihar segment of the aforementioned project. In this context, she has been involved in the organisation of three collaborative workshops and two public lectures in 2017 and a collaborative workshop in 2018. She has prepared quarterly reports for the project in 2017 and continues to do so in 2018 in addition to the monthly reports that have been introduced in the current year. In addition, she has been a researcher in the Social Mapping of Infrastructure, Logistics and India's Look East Policy segment of the larger project on Social and Political Mapping of Popular Movements, Logistical Vision and Infrastructure of India and has published a working paper on Representations of connectivity: the politics and economics of routes in the Asian context (Policies and Practices, 84), another version of which is expected to be published by Routledge as a book chapter as part of the publication for the project. She is also an editorial assistant for *Refugee Watch*, the biannual, peer-reviewed journal of CRG. She has assisted in the publication of issue Nos. 48, 49 & 50 and the forthcoming issue on Rohingyas (No 51). She has contributed an essay entitled, A Colonial, Modern and Urban Interface: Jaffa and the Politics of Exclusion in issue no 50 of the journal. Priya also deals with the 'Global Partnership for the Prevention of Armed Conflict (GPPAC)' desk at CRG. She is a part of the team that handles the Facebook page of CRG for purposes of dissemination of its programmes. Priva is an Associate of the Distinguished Chair for Migration and Forced Migration Studies at CRG as well.

Aditi Mukherjee is a Research and Programme Associate working on the CRG-RLS project *Research* and Orientation Workshop and International Conference on The State of the Global Protection System for Refugees and Migrants. She is a final year PhD student at the Leiden University. Her doctoral research draws on ethnographic research conducted at different types of migrant dwellings in periurban Calcutta to address questions of different modalities of displacement and tiers of migrant/urban citizenship within third world metropolitan contexts. At MCRG she facilitates correspondence with participants, helps in formation of agendas for meetings related to the forced migration workshop and conference. She, along with other MCRG colleagues looks, into the logistical sides of the November event, e.g. booking of venue and accommodation.

**Shatabdi Das** has been working with Calcutta Research Group as Research and Programme Assistant for the CRG-RLS project *Social and Political Mapping of Popular Movements, Logistical Vision and Infrastructure of India* since March, 2018. She has worked on the compilation of summary report, editorial assignments for book publication and proofreading of CRG journal issues. She is entrusted with keeping minutes of meetings, circulation of workshop and conference notification. She has participated in collaborative workshops and has helped in preparation of participant feedback report, and has also written an article on the interview excerpts of a key speaker in the conference.

**Apala Kundu** is Research and Program Assistant at Calcutta Research Group for the CRG-RLS project *Research and Orientation Workshop and International Conference on The State of the Global Protection System for Refugees and Migrants* since April 2018. Her work profile includes communicating with the participants, responding to their queries and providing them with necessary information. In a general capacity, she also does rapporteuring, prepares posters and reports pertaining to CRG seminars and conferences, and does editorial work for CRG's publications. She has previously worked as Conference Assistant at CRG on the project 'Capital in the East: A Conference on Marx's Capital after 150 Years of Its Publication' wherein she communicated with the participants, prepared the poster, schedule, brochure and the final report of the conference, and continues to work with the editors to facilitate the publication of the conference volume.

**Ankita Manna** is Research and Program Assistant at Calcutta Research Group for the CRG-RLS project *Social and Political Mapping of Popular Movements, Logistical Vision and Infrastructure of India* since February 2018.Her work profile includes report writing, rapporteuring at seminars and conferences, poster design and various other works as assigned. She has written a report on the extent and causes of illiteracy and dropouts of women's education in Sundarban, Bali Island at the behest of Krishna Memorial Trust. She is the convener of Friday Lecture and is assigned with sending out lecture and conference invitations, creating database and other managerial work.

## 7.2 Office Staff

In February 2018, our Office Secretary, Mrs Manjuri Chatterji suffered severe illness and was unable to rejoin office. Keeping in mind her long years of service at CRG, the finance sub-committee recommended an ex-gratia payment of one lakh to be given to her. Advertisement for appointment of a new Office Secretary has been made. Ratan Chakraborty was given additional charge of Acting Office Secretary from 1 April 2018 while continuing with his functions as Accounts and Administrative Officer. The services of Samaresh Guchhait and Ashok Kumar Giri were retained. The part-time service of R. K. Mahato as typist was also retained till November 2017. From 1 December 2018, he joined as part time Library Assistant.

Members will be happy to know that as per the recommendation of the Governing Body, the administrative and research staff members of CRG were given an additional 10% raise in their salary when their service contracts were renewed. This was done towards development of the skill of the CRG office and research staff and on the basis of a plan for utilising half of the annual interest accruing from the CRG corpus fund. Besides this, a one-time contribution of Rs 20,000 was granted towards their social security. In addition, they received as usual office contribution to their respective PPF accounts and reimbursement of their medical insurance expenses.

#### 7.3 Other Office Matters

#### Finance Sub-Committee

Under the direction of the Governing Body, the Finance Sub-Committee was reconstituted. It now includes the Treasurer, V. Ramaswamy, the Secretary, Sibaji Pratim Basu, and Shyamalendu Majumdar, Arup Sen, Samata Biswas and Anita Sengupta as members.

#### Communications Committee

A Communications Committee was formed as per recommendation by the AGM in 2017. Under this a website committee was formed by the Governing Body consisting of Priya Singh, Samata Biswas, V Ramaswamy and Anita Sengupta who were instrumental in redesigning the website of CRG and are now engaged with merging Refugee Watch and Refugee Watch Online on a single platform.

## SECTION EIGHT Concerns and Call for Collaborations

CRG has entered the lean period of scarce funding. The Governing Body, the Finance Sub-Committee, and senior members are aware of the situation. CRG is taking steps to rationalise all its expenses. It is also taking measures to focus on funding sources, publicise its work more, interact with policy community to a greater manner, and approach other funding agencies. Members are requested to come forward to collaborate in fundraising in different ways. In view of the austerity measures required to be adopted, members are requested to volunteer for some of the work (for instance, helping with publications, preparing e-briefs, running e-bulletins, circulating information, etc.) currently being done by CRG office staff under extreme strain. Only with greater participation of CRG society members can the institution grow amidst the difficulties. CRG is always happy to collaborate with and assist its members in any way possible. It would be required that its members also extend the same collaboration to CRG. In the AGM held in August 2015 (following the 35<sup>th</sup> meeting of the Governing Body held on 23 August 2015) it was decided 'when taking up any assignment involving and affecting CRG a member should be aware of and avoid any possible conflict of interest, and should consult the Secretary accordingly'. While it cannot be imposed, we would, once again, request our members to keep this in mind.

## SECTION NINE Roll of CRG members

Members will be delighted to know that Samita Sen, our Board Member, has been offered the the Vere Harmsworth Professorship of Imperial and Naval History at Cambridge. Paula Bannerjee, our former Director has joined as Vice Chancellor of Sanskrit University and Sanjay Chaturvedi has been appointed Professor and Chairperson, Department of International Relations, South Asian University.
